



AAM Reports Third Quarter 2022 Financial Results

AAM Continues To Deliver Positive Free Cash Flow Under Current Industry Conditions

DETROIT, November 4, 2022 -- American Axle & Manufacturing Holdings, Inc. (AAM), (NYSE: AXL) today reported its financial results for the third quarter 2022.

Third Quarter 2022 Results

- Sales of \$1.54 billion
- Net income of \$26.5 million, or 1.7% of sales
- Adjusted EBITDA of \$198.4 million, or 12.9% of sales
- Diluted earnings per share of \$0.22; Adjusted earnings per share of \$0.27
- Net cash provided by operating activities of \$85.2 million; Adjusted free cash flow of \$45.8 million

“We remain focused on consistent cash flow generation as we navigate near-term industry volatility stemming from ongoing semiconductor and supply chain challenges,” said AAM’s Chairman and Chief Executive Officer, David C. Dauch. “In addition, our objective is to build long-term shareholder value through innovative engineering development, evidenced by our recent PACE Award wins for our electric drive technology.”

AAM’s sales in the third quarter of 2022 were \$1.54 billion as compared to \$1.21 billion in the third quarter of 2021. On a year-over-year basis, sales for the third quarter of 2022 were favorably impacted from the recent Tekfor acquisition and volume and mix.

AAM’s net income in the third quarter of 2022 was \$26.5 million, or \$0.22 per share, as compared to a net loss of \$(2.4) million, or a loss of \$(0.02) per share in the third quarter of 2021. Adjusted earnings per share in the third quarter of 2022 was \$0.27 compared to \$0.15 in the third quarter of 2021.

In the third quarter of 2022, Adjusted EBITDA was \$198.4 million, or 12.9% of sales, as compared to \$183.2 million, or 15.1% of sales, in the third quarter of 2021.

AAM’s net cash provided by operating activities for the third quarter of 2022 was \$85.2 million as compared to \$89.8 million for the third quarter of 2021.

AAM’s Adjusted free cash flow for the third quarter of 2022 was \$45.8 million as compared to \$69.1 million for the third quarter of 2021.

AAM's 2022 Updated Financial Outlook

AAM's full year 2022 financial targets are as follows:

- AAM is targeting sales in the range of \$5.75 - \$5.85 billion vs. \$5.75 - \$5.95 billion prior.
- AAM is targeting Adjusted EBITDA in the range of \$745 - \$765 million vs. \$790 - \$830 million prior.
- AAM is targeting Adjusted free cash flow of approximately \$300 million vs. \$300 - \$350 million prior; this target assumes capital spending of approximately 3.0% - 3.5% of sales.

These targets are based on the following assumptions for 2022:

- In addition to normal production seasonality, we expect the fourth quarter operating environment to be similar to that experienced in the third quarter, including the continuation of higher than previously anticipated volatility in truck production.

In addition to the results reported in accordance with accounting principles generally accepted in the United States of America (GAAP) included within this press release, AAM has provided certain information, which includes non-GAAP financial measures such as Adjusted EBITDA, Adjusted earnings per share and Adjusted free cash flow. Such information is reconciled to its closest GAAP measure in accordance with Securities and Exchange Commission rules and is included in the attached supplemental data.

Certain of the forward-looking financial measures included in this earnings release are provided on a non-GAAP basis. A reconciliation of non-GAAP forward-looking financial measures to the most directly comparable forward-looking financial measures calculated and presented in accordance with GAAP has been provided. The amounts in these reconciliations are based on our current estimates and actual results may differ materially from these forward-looking estimates for many reasons, including potential event driven transactional and other non-core operating items and their related effects in any future period, the magnitude of which may be significant.

Management believes that these non-GAAP financial measures are useful to management, investors, and banking institutions in their analysis of the Company's business and operating performance. Management also uses this information for operational planning and decision-making purposes.

Non-GAAP financial measures are not and should not be considered a substitute for any GAAP measure. Additionally, non-GAAP financial measures as presented by AAM may not be comparable to similarly titled measures reported by other companies.

Definition of Non-GAAP Financial Measures

AAM defines Adjusted earnings per share to be diluted earnings per share excluding the impact of restructuring and acquisition-related costs, debt refinancing and redemption costs, loss on sale of business, impairment charges, pension settlements, certain accelerated depreciation, unrealized gains or losses on equity securities and non-recurring items, including the tax effect thereon.

AAM defines EBITDA to be earnings before interest expense, income taxes, depreciation and amortization. Adjusted EBITDA is defined as EBITDA excluding the impact of restructuring and acquisition-related costs, debt refinancing and redemption costs, loss on sale of business, impairment charges, pension settlements, unrealized gains or losses on equity securities and non-recurring items.

AAM defines free cash flow to be net cash provided by operating activities less capital expenditures net of proceeds from the sale of property, plant and equipment. Adjusted free cash flow is defined as free cash flow excluding the impact of cash payments for restructuring and acquisition-related costs, and cash payments related to the Malvern fire, including payments for capital expenditures, net of recoveries.

- (a) We define EBITDA to be earnings before interest expense, income taxes, depreciation and amortization. Adjusted EBITDA is defined as EBITDA excluding the impact of restructuring and acquisition-related costs, debt refinancing and redemption costs, loss on sale of a business, impairment charges, pension settlements, unrealized gains or losses on equity securities and non-recurring items. We believe that EBITDA and Adjusted EBITDA are meaningful measures of performance as they are commonly utilized by management and investors to analyze operating performance and entity valuation. Our management, the investment community and the banking institutions routinely use EBITDA and Adjusted EBITDA, together with other measures, to measure our operating performance relative to other Tier 1 automotive suppliers. We also use Segment Adjusted EBITDA as the measure of earnings to assess the performance of each segment and determine the resources to be allocated to the segments. EBITDA and Adjusted EBITDA are also key metrics used in our calculation of incentive compensation. EBITDA and Adjusted EBITDA should not be construed as income from operations, net income or cash flow from operating activities as determined under GAAP. Other companies may calculate EBITDA and Adjusted EBITDA differently.
- (b) We define Adjusted earnings per share to be diluted earnings per share excluding the impact of restructuring and acquisition-related costs, debt refinancing and redemption costs, loss on sale of a business, impairment charges, pension settlements, certain accelerated depreciation, unrealized gains or losses on equity securities and non-recurring items, including the tax effect thereon. We believe Adjusted earnings per share is a meaningful measure as it is commonly utilized by management and investors in assessing ongoing financial performance that provides improved comparability between periods through the exclusion of certain items that management believes are not indicative of core operating performance and which may obscure underlying business results and trends. Other companies may calculate Adjusted earnings per share differently.
- (c) In the first quarter of 2021, one of our largest customers announced their intention to cease production operations in Brazil in 2021 as part of their restructuring actions. As such, we accelerated depreciation on certain property, plant and equipment beginning in the first quarter of 2021.
- (d) We define free cash flow to be net cash provided by operating activities less capital expenditures net of proceeds from the sale of property, plant and equipment. Adjusted free cash flow is defined as free cash flow excluding the impact of cash payments for restructuring and acquisition-related costs and cash payments related to the Malvern fire, including payments for capital expenditures, net of recoveries. We believe free cash flow and Adjusted free cash flow are meaningful measures as they are commonly utilized by management and investors to assess our ability to generate cash flow from business operations to repay debt and return capital to our stockholders. Free cash flow and Adjusted free cash flow are also key metrics used in our calculation of incentive compensation. Other companies may calculate free cash flow and Adjusted free cash flow differently.
