AAM Direct Material Shipments - ASN and Labeling Non-Compliance

AAM requires all direct material suppliers to be complaint with the new supply chain process. At a high level compliance with the new process involves the following

For Suppliers using EDI

- 1. Supplier receives all DELFOR, DELJIT, APERAK and RECADV generated and sent by AAM
- 2. Supplier generates and sends CNTRL for all received documents
- 3. Supplier sends correct DESADVs on time
- 4. Supplier ships with appropriate AAM GTPL labels container and master receiving labels on all containers and pallets
- 5. Information on DESADV and AAM GTPL labels match

For Suppliers using the AAM Portal

- 1. Supplier sends correct ASN on time
- 2. Supplier ships with appropriate AAM GTPL labels container and master receiving labels on all containers and pallets
- 3. Information on ASN and AAM GTPL labels match

Non-Compliance with the new process may result in PRRs and cost recovery.

<u>AAM ASN Validation</u> (The following apply to EDI suppliers only)

All ASNs received by AAM are validated for compliance. There are two kinds of validation

- Formatting: The DESADV document will be checked for format compliance. Any deviation will result in the DESADV being rejected by our EDI Translator GXS. GXS will send a control document and optionally an email to the supplier if the DESADV is rejected.
- Data: If your DESADV complies with the formatting rules, it will then be checked for data accuracy. Inaccurate data will result in your DESADV being rejected. You will be sent an APERAK. The following are the DESADV validation rules.
